## Dinner on the Grounds

One custom that reaches back into the early days of Frankford Cemetery is dinner on the grounds. This custom took place on Decoration Day in May and began as early as the late 1890's. On that day people traveled from near and far to clean the graves and decorate them with fresh flowers from the fields and gardens of association members.

In the early days people from a distance came by horse drawn wagon for the weekend. This event served a very practical need in caring for the graves in the cemetery as well as providing a social outlet for people who didn't get to see each other often.

The highlight of Decoration Day weekend was dinner on the grounds, with delicious food prepared by Frankford ladies. Tables laden with fried chicken, mashed potatoes, fresh green beans from members' gardens, and wonderful desserts were set out on the meadow south of the church.

John Wells remembered always looking forward to dinner on the grounds as a young boy. To him it was almost as exciting as Christmas. Leslie Noell remembered playing games with other kids near the creek on that day. Marguerite Shaw Cook White still recalls the rousing singing of old hymns in the church. A preacher reminded those who gathered in the little church of the importance of heritage and faith and honoring those who had come before.

On November 2, 2008, Frankford Cemetery Association revives the observance of Dinner on the Grounds. Members of the Frankford community will not arrive by horse drawn wagon, but we will have fried chicken, chicken fried steak and all the fixin's. We hope to evoke the spirit and sense of community of the old Frankford Church dinners on the grounds.

## FCA Projects

Listed below are some of the many projects the FCA Board completed in the last five months. The last item under *Church* is in the planning stage.

### Grounds

1) Correcting a severe drainage problem on the east side of the cemetery. The Board hired a landscape designer who specializes in drainage issues to implement a plan devised by an engineering firm hired by the previous board. The plan involved creating a swale to divert the water that collects in the eastern part of the cemetery so that it will flow naturally from the north to the south side of the cemetery and out to Harbor Town Drive. At this writing the contouring of the dirt is done and we are ready place a pipe at the south of the cemetery to drain the water out to the street and sod the new swale.

2) Mowing the cemetery and grounds more often during the growing season. Making repairs to the sprinkler system. Removing fallen tree limbs and pruning in the cemetery and by the creek.

3) Placing signs on the northeastern and northwestern sides of the cemetery stating that dogs are not allowed in the cemetery.

### Church

1) Repairing a hole in the bell tower that was left when the Church of the Holy Communion removed the bell they had paid for and installed years ago.

2) Installing a fire and burglar alarm system in the church.

3) Installing termite bait stations around the outside of the church. The pest control company found no active termites but did find evidence of termite damage in the past.

4) Hiring a professional cleaning service to thoroughly clean the inside of the church.

5) On September 13, 2008, the Board met with Architexas, an architecture firm that

specializes in restoring old buildings. The current Board is interested in carefully restoring the church without sacrificing the historic integrity of the building. We also discussed building a meeting hall with restrooms, a place for a bride to change, etc.

## History of Frankford Property Leases

Frankford community ladies Ellen Simpson McKamy and Emma McKamy Dye gave two tracts of land to the FCA that now provide the majority of the annual income for the association. These two tracts of land are referred to as the "Wood Lot" (now on Westgrove Drive) and the "Bull Pen" on Dallas North Toll Road and Addison Road south of Trinity Mills. The colorful names reflect the original use of the properties.

Mrs. McKamy and Mrs. Dye were thoughtful and forward thinking many decades ago in gifting the properties for the purpose of providing revenue for the upkeep and care of the cemetery. Mrs. Dye's lease allows the balance of the lease funds to be used at the discretion of the Cemetery Association. These two benefactors could not have foreseen the surrounding development that enclosed their beloved Frankford. However, because of their generosity the FCA can maintain, preserve, and protect the historic cemetery and church. The Frankford Community is grateful.

Negotiations for renewal of the leases are underway. The following chart is an estimated value of the leases.
