IN THE YEAR 2000 THE EPISCOPAL CHURCH CAME TO THE BOARD AND SAID THEY WERE GOING TO BUILD A NEW CHURCH AND SUGGESTED THAT A MASTER PLAN BE DEVELOPED TO OPTIMIZE THE USE OF THE BOTH PROPERTIES. AN OUTSTANDING LANDPLANNING FIRM WAS HIRED TO HELP WITH THE FORMULATION OF A PROGRAM AND SUBMITTED SEVERAL OPTIONS TO THE CHURCH AND THE BOARD. OVER THE NEXT TWO YEARS NUMEROUS MEETINGS WERE HELD AND INPUT WAS SOLICITED FROM THE MEMBERSHIP. FINALLY IN 2002 A MASTER PLAN WAS ADOPTED AND PRESENTED TO THE MEMBERSHIP AT THE ANNUAL MEETING ON THE THIRD SUNDAY IN MAY. AT THE SAME TIME IT WAS ADOPTED BY THE CHURCH AND JOINT USE AGREEMENTS PREPARED AND EXECUTED.

THE NEW CHURCH WAS DEDICATED A FEW WEEKS AGO AND SERVICES ARE NO LONGER HELD IN THE OLD PIONEER CHURCH. THE BOARD IS TAKING STEPS TO GRADUALLY IMPLEMENT THE MASTER PLAN. A NUMBER OF PEOPLE HAVE COME FORWARD AND ASKED TO EXPRESS THEIR OPINIONS. ON 23 APRIL A WELL PUBLICIZED MEETING WAS HELD TO HEAR THOSE OPINIONS AND TO ANSWER ANY QUESTIONS. OF PARAMONT IMPORTANCE WAS THE FUTURE OF THE OLD ADDISON DEPOT. THE CITY OF ADDISON HAS EXPRESSED AN INTEREST IN MOVING IT BACK TO ADDISON AND THIS APPEARS TO BE THE BEST ALTERNATIVE. THE BOARD WELCOMES AND SOLICITS YOUR OPINIONS BUT IN THE END IT MUST ACT IN WHAT IT CONSIDERS THE BEST INTERESTS OF PROTECTING AND PRESERVING OUR HERITAGE.
