## FRANKFORD STORIES

#### FRANKFORD PROJECTS

Following are some of the projects the FCA Board completed during the past year:

- Re-rocked the road north of the cemetery, creating a turnaround at the eastern end of the road to help people enter and exit the cemetery.
- Added a "wing" to the east end of the drive through the middle of the cemetery to help people exit.
- Leveled "sunken" or crooked cemetery monuments.
- Applied for and received the Texas Historical Commission's designation as a Texas Historic Cemetery, the highest honor for historic Texas cemeteries.
- Planted forty-nine native trees along the northern and eastern boundaries of the Frankford site.

### **DONATIONS FOR PROJECTS**

The FCA Board welcomes donations for the following projects:

- This past year we leveled sunken and leaning cemetery monuments. We strive to keep the monuments in good repair, and due to shifting soil the monuments need to be leveled periodically. This project was expensive so we hope some lot owners will help offset the cost. Completing this project benefits the look of the entire cemetery and prevents monuments from completely falling down in the future.
- In the next year we hope to plant native trees in some of the "bare spots" of the cemetery. If you would like to contribute toward the general cost of this project or specifically pay for a tree to be added near your burial space, the board will be grateful for your contribution. All trees added to the cemetery will be natives appropriate for our soil and climate. Landscape architect Rosa Finsley will be the consultant for all trees added to the cemetery.

## CEMETERY COURTESY AND PROTOCOL

On Decoration Day weekend many Frankford families will visit the cemetery to place flowers on the graves of loved ones. With just one main access into the cemetery (the concrete drive in the middle) it is easy for vehicles to get wedged in between other vehicles and unable to exit the cemetery. To avoid this frustrating situation the board asks everyone decorating graves or visiting the cemetery during Decoration Day weekend to follow this protocol:

Please park outside the cemetery if at all possible. If you must park on the drive in the middle of the cemetery, please no more than two vehicles on the drive at a time. Be alert to the need to back out your vehicle if the person in front of you is ready to leave.

Please, no vehicles on cemetery grounds (other than the concrete drive). Funeral home vehicles are the only vehicles allowed on the cemetery grounds. Thank you for your cooperation.

At the Frankford Cemetery Association annual business meeting on May 15, 2011, the members present approved new by-laws presented by the Board of Directors.

One of the changes is our ability to enlarge our *voting* membership. The previous by-laws allowed voting rights to lot owners only.
